

## "You cannot play when you are hungry ... If you play with hunger, you feel weak."

Playing was the furthest thing from Ayen's mind when she rushed her baby sister Nyajuba – suffering from severe acute malnutrition – to a Save the Children stabilisation centre for life-saving treatment.

At just 15, Ayen understood what it means for a child's life to be in danger after seeing her baby sister fall ill. Ayen told us: "Nyajuba became so weak that she had vomiting and diarrhoea, a high fever, and a cough. She was not playing because she was not feeling well."

Ayen's remote community in South Sudan has been gripped by tragedy: a succession of floods – fuelled by the changing climate – have destroyed crops and swept away Ayen's family home. Families have been left with nothing.

Thanks to Ayen's quick actions her 9-month-old sister received the special 'plumpy nut' diet and medical treatment she needed. Now she is fully recovered and making Ayen laugh again. "I was very happy when she recovered. I like the way she always laughs when we play."

Thanks to the incredible generosity of our supporters, the work of Save the Children is transforming young lives all around the world.



## Why do I need a Will?

Ideally everyone should have a Will. Your Will reflects who and what is important to you and gives assurance that the people and causes you care about will be provided for, according to your wishes. However, when anyone in Australia dies without a Will, their assets are distributed according to a set formula enacted by their state and territory laws and may not reflect their wishes.

## Including Save the Children in your Will is not difficult

All you need is our ABN 99 008 610 035 and registered name - Save the Children Australia.

If you decide to include Save the Children in your Will, there are three types of gift you can consider:

- A 'residuary gift' is a percentage of the residue of your estate once your other wishes have been carried out;
- A 'monetary gift' is a fixed dollar amount;
- A 'specific gift' is a possession or item (such as shares or property).

Many of our supporters choose to include a residuary gift as this ensures that their loved ones always take priority and because even a small percentage of what remains can make a profound difference to our work. Also, unlike a monetary or specific gift, the value of a residual gift is less likely to decrease because of inflation.

Here is some suggested wording you may wish to consider using in your Will:

I give to Save the Children (ABN 99 008 610 035), of Level 9, 469 La Trobe Street, Melbourne, Victoria, 3000, a gift of (insert your choice of a percent share of your residuary estate or specific sum) for its general purposes.
