HOW A GIFT IN YOUR WILL CAN HELP HEAL THE HORROR

“I had told my son to leave South Sudan, or at least to send the children away, but he answered me he wanted to wait because he hoped something would have changed.

Nothing changed.

The conflict came and my son and his wife were killed in front of their oldest children. Then they were burned in their house.

I was so scared. I decided to take my children and try to escape to Uganda.

But whenever you try to run away from South Sudan, you bump into soldiers who ask you money. If you try to escape, they kill you. If you don't have any money, they take everything you have, including your clothes. You stay there completely naked.

We walked for nine days. I carried the youngest children on my shoulders, and I took the oldest ones by the arm.

When we arrived at the Impevi Camp, I knew we were saved. But it is still hard. The two oldest children have been witnesses of the facts, so now it is not easy for them because they saw everything.

I thank God the other two youngest boys don't even know what really happened to their parents.

The children now go to a place made by Save the Children called “Child Friendly Space”. Here they are safe and protected. They play games, sing songs and do art. They interact with the other children, and I pray one day the injuries they suffered will heal.”

PROOF OF LIFE

“I first got to know Save the Children when I was at primary school, and we raised money to help children in danger.

Now, as a retired business leader, I am impressed how switched on the organisation is. There’s more than 100 years of experience here that’s handed down, so things are done properly, and don’t have to be relearned from scratch all the time.

I saw this for myself when I visited Laos as part of a team from Salmat, where I was Head of People and Culture, and we supported Save the Children programs. A project we saw protected children through the first three years of life.

What encouraged me was the way Save the Children supported and equipped locals to run things. This meant they had ownership, which made the program successful and sustainable.

The proof? Deaths in childbirth, and deaths in the first three years of life, were the lowest of any province in Laos. Then, because the program was owned by the locals, Save the Children was able to move on and help children in other areas.

The reason I decided to leave a gift in my Will to Save the Children is because I want children to have a better world.

The fact is there are always going to be children who need our care. Children who need help. Children who need protection. Children whose rights are being abused. Through the gift in my Will I know I can keep helping these children.

I know too I can trust Save the Children to get the job done, appropriately and well.

When you’re looking at your estate - and everybody has to confront that issue - your first priority is going to be family.

I’m blessed to come from a very large family, and have lots of nieces and nephews, great-nieces, great-nephews. I hope what I do through Save the Children can be an example to them, and they see the absolute joy that comes in giving and providing service to others.

Nelson Mandela once observed, ‘Education is the most powerful weapon you can use to change the world.’

That’s why your help for children to go to school in poor communities overseas is so important ...

... and just as vital for at-risk children here in Australia - children who suffer anxiety, or face challenges at home, or simply feel left out. Like Chloe. She used to struggle at school. Now, through Save the Children’s Cool4School program Chloe can visit a trained educator, who uses techniques like mindfulness and therapy pets to keep her calm and ready to learn.

By protecting children like Chloe from poverty, abuse or neglect, you give them a future filled with hope and opportunities. As Chloe’s classmate, Ryan, shares:

YOU CARE FOR FIRST NATION CHILDREN

Craig is a dad from the remote Aboriginal community of Doomadgee in the Gulf Country of Queensland. He works with the Police Citizen’s Youth Club (PCYC). Through Save the Children, a gift in your Will can support children like Craig’s to be successful at school.

“Save the Children does a lot of good work in the community. They are always the first ones to be out there because we are very community and youth-oriented at PCYC. We work together on a lot of stuff.

Children have to know where they come from. There are rules in our culture that will carry them through life out there in the scrub. All the stuff that my father, my uncle and mother taught me, and my grandfather taught me when I was young, I get to teach my children now. And it’s a very rewarding thing when you show something to your kids this week, and next week they learn to do it themselves.

Education is very important. I got higher education myself. It made me the man that I am today. Got a good job. Strong and providing for my family. I’m set. I’ll give my kids that same path to walk down and hopefully they turn out the same.”

YOU PROTECT THE SMALLEST

“My name is Rolina. I have two girls and one boy. In the past we would only prepare staple foods and supplemented them with canned meats, thinking it was nutritious for our kids. When we attended the Save the Children workshop we learned we have different varieties of nutritious foods in our gardens, which we do not need to spend our money on.

I have learnt a lot with MYBebi program, such as caring and providing proper feeding practices for children, taking care of their health.

I have a recipe book from Save the Children. It’s easy to follow and our kids have very much enjoyed the balanced meal we prepared for them.

I have observed a big change among these kids with these nutritional changes. The proper feeding techniques have impacted the growth and development of our children, which is really impressive.”

YOU CREATE LONG-TERM CHANGE

“The conflict hit us hard. The armed groups came and took everything – our cows, our goats, our food, our clothes. Two of my cousins were killed as they tried to defend our home.

I was lucky not to be there as they were looking for young girls. They wait for you in the bush and grab you. When I was 13, my uncles wanted to give me away in marriage in exchange for cows. My mother refused. I wanted to stay in school.

Last year at church there was an announcement that there were vacancies at the Save the Children Activity Centre. I chose to study welding. The income is higher than hairdressing or agriculture.

People told me it was not woman’s work, and that I would not handle it. But once they saw I could make useful things, and earn money, no one tried to control me.

The Activity Centre has given me freedom. I plan to start a welding workshop with my friend Maisie.”

YOUR QUESTIONS ANSWERED

Your Will is one of the most important opportunities of your life. Once you take care of your family and loved ones, you can then bless others in a way that honours your life’s values.

Is it hard to make a Will?

Making a Will is surprisingly easy to do. You simply visit a solicitor or legal adviser and they can make sure your wishes are honoured in your Will – including leaving a gift in your Will to Save the Children, using the wording on page 16.

How can I be certain a gift in my Will really saves children?

Save the Children has more than 100 years of experience working with children in the most dangerous and difficult places. We have learned how to be effective, how to meet challenges, how to keep going even when it’s tough. We care for children in emergencies as well as long-term projects, and we work in partnership with communities and other organisations to be the most efficient and use resources and expertise effectively.

Isn’t my Will private?

Absolutely! Save the Children recognises what a personal and important decision it is to make your Will, and we respect your privacy. While being personal, it is a good idea to tell your

family about any decision you make to leave a gift in your Will to Save the Children. That way they can know your wishes, and understand your gift of kindness to children. It is also helpful if you can let Save the Children know, in confidence, about any gift you leave for the world’s children – we’d like to thank you properly!

How will my gift be used?

We will use your gift where it’s needed most at the time so it can have the greatest impact for children. We promise to use your gift carefully and cost effectively to make sure children are safe, healthy and on track for a positive future wherever they are – in every corner of the country and in some of the most remote places on earth. Whatever the future holds, your gift will make it better for children.

Do I need to update my Will if I decide to add a gift to Save the Children?

Life changes! So it is always important to check your Will is up-to-date, and does what you want it to do. You should review it as your circumstances change. If you’re happy with your Will, your solicitor or legal adviser can help you update your Will for a gift to Save the Children to leave a better world for children.
